

PRIVACY STATEMENT
pursuant to article 13 of Regulation (EU) 2016/679

The Ca' Foscari University of Venice, within the scope of its institutional purposes and in fulfilment of the obligations under Art. 13 of Regulation (EU) 2016/679 ("Regulation"), provides you with information on the processing of personal data of legal representatives and company contacts provided to register for the "Career Day Settoriali", intended to facilitate the matching of labour demand and supply (hereinafter also "Event").

Online registration and participation in the Event take place through the "MITO" platform managed by the AlmaLaurea Consortium, in its capacity as Data Processor. The University also informs you that the data provided during registration on the aforementioned platform and participation in the Event shall be used by the Consortium in further processing for its own specific purposes as independent Data Controller (for more details, please see the privacy statement of the AlmaLaurea Consortium available in Italian at the following link: <https://www.almalaurea.it/info/condizioni/privacy/informativa-d13bis>).

1) DATA CONTROLLER

The Data Controller is the Ca' Foscari University of Venice, with head offices in Dorsoduro no. 3246, 30123 Venice (VE), in the person of the Rector.

2) DATA PROTECTION OFFICER

The University has appointed a "Data Protection Officer", who can be contacted by writing to the email address dpo@unive.it or to the following address: Ca' Foscari University of Venice, Data Protection Officer, Dorsoduro 3246, 30123 Venice (VE), Italy.

3) CATEGORIES OF PERSONAL DATA, PURPOSE AND LEGAL BASIS OF DATA PROCESSING

The processing in question involves the provision of the personal and contact details of the legal representatives and company contacts of the companies and entities participating in the "Career Day Settoriali".

The personal data is processed for the purpose of the stipulation and execution, through participation in the Event, of an agreement concerning services of intermediation between labour supply and demand, in order to promote the professional placement of Ca' Foscari students and graduates pursuant to Italian Law no 183 of 4 November 2010 ("related work") and Law no 111 of 15 July 2011 (Art.29); the personal data shall also be processed by the University for promoting future placement events pursuant to the aforementioned legislation.

Data subjects may object to data processing in relation to the promotion of future events at any time, by writing to the Personal Data Protection Officer at the addresses indicated above. The University shall refrain from further processing the personal data unless there are compelling reasons that legitimise the continuation of the processing.

The legal bases of this processing are given in Art. 6.1.b) of the Regulation ("performance of a contract to which the data subject is party") and by Art. 6.1.e) ("performance of a task carried out in the public interest"). The processing of personal data is based on the principles of fairness, lawfulness and transparency and on the protection of the privacy and rights of the party concerned, as well as the additional principles provided for by Art. 5 of the Regulation.

4) PROCESSING METHOD

Personal data shall be processed by employees and collaborators of the University, who act according to specific instructions regarding the purposes and methods of the processing (in compliance with the provisions of Art.29 of the Regulation and Art. 2- *quaterdecies* of Legislative Decree no.196 / 2003), using procedures, including computerised procedures, adopting adequate technical and organisational measures to protect them from unauthorised or unlawful access, from destruction, from loss of integrity and confidentiality, even accidental.

5) RETENTION PERIOD

The personal data shall be kept by the University for one year for the purpose of carrying out the "Career Day Settoriali" and for the promotion of future placement events.

6) RECIPIENTS AND CATEGORIES OF RECIPIENTS OF PERSONAL DATA

For the aforementioned purposes, personal data shall be processed both by specifically authorised employees and collaborators of the University and by the AlmaLaurea Consortium, as both Data Processor with reference to the management of the “MITO” platform, and independent Data Controller in relation to additional specific purposes outlined in greater detail in the specific information provided by the aforementioned Consortium.

7) PROVISION OF DATA

The provision of the aforementioned personal data is necessary to enter into a contract of intermediation services with the University and to participate online in the “Career Day Settoriali”.

8) RIGHTS OF DATA SUBJECTS AND PROCEDURES FOR THEIR EXERCISE

As data subject, you have the right to obtain from the university, in the circumstances provided for by the Regulation, access to personal data, rectification, completion and erasure of said data or the restriction of processing, or the right to object to the processing (Articles 15 et seq. of the Regulation). The request can be made, without any formalities, by contacting the Data Protection Officer directly at dpo@unive.it or by writing to the following address: Ca' Foscari University of Venice - Data Protection Officer, Dorsoduro 3246, 30123 Venice, Italy. Alternatively, you can contact the Data Controller by sending a certified email (PEC) to protocollo@pec.unive.it.

Data subjects who believe that the processing of personal data concerning them is undertaken in violation of the provisions of the Regulation also have the right to lodge a complaint with the Italian Data Protection Authority, as established by Art. 77 of the Regulation, or to an effective judicial remedy (Art. 79 of the Regulation).

With regard to the processing performed by the AlmaLaurea Consortium as independent Data Controller, please refer to the information provided by the Consortium.
