From 1992 to 2001 he held a wide range of managerial positions at JP Morgan in Milan and London, with responsibility for Italian Markets Activities, Fixed Income Trading, Emerging Markets, East European, Middle East and Africa Local Markets and European Government Bonds.

From 2004 to 2010, he has been professor at "Carlo Cattaneo – LIUC" University of Castellanza (Varese).

His past responsibilities include serving as Chairman of the "Commissione Tecnica per la Finanza" (Financial Technical Committee) of ABI (Italian Banking Association) from 2006 to 2007, Board Member of Borsa Italiana S.p.A. from 2001 to 2007, MTS (European Bond Exchange) from 2001 to 2006, EuroMTS (2002-2006) and ISDA (International Swaps and Derivatives Association) from 2006 to 2007.
