As reported in the document *Info services offered 2025-26*, the monthly fee includes utilities (heating, electricity, water, waste), administrative and service personnel, secretariat, management taxes, insurance, supply of linens (sheets/pillowcases /covers/towels), maintenance (excluding damage caused by guests), administrative fees. All personal goods (e.g. food, detergents, etc.), the *Printing service* and anything else that is not expressly specified remain at the expense of the student.

METHODS OF PAYMENT

At the time of acceptance, following the submission of the *Application for Admission*, and the signing of the *Letter of Commitment*, the *Internal Regulation* and this *Economic Note*, you will be asked to pay the following: a) **Enrollment fee**, b) **Residence tax** and **Two fees, one of which is the last contractual monthly payment and one is a deposit.**

For example, to **book** a bed in a triple room for the entire academic year, the transfer amount will be equal to:
 $200€ + 15€ + 460€ \times 2 = 1.135€$

The admission will be considered confirmed only after our bank account matched the payment or when the student sent us by email the receipt of the bank of that payment.

The contract binds the signer for the required months and the early withdrawal, for any reason, does not release contractual obligations and does not result in the return of the fees relating to the monthly payments paid in advance or deposit. Monthly payments must be made **at the beginning of each month, no later than day 5.**

The fee will remain fixed if the consumer price index FOI (Index for families of workers and employees), cumulative starting from the month of SEPTEMBER 2025, does not increase by more than 2,5%. If the cumulative FOI exceeds 2,5%, the fees will be increased monthly by the difference between the cumulative figure and 2,5%.
