A.Y. 2024-2025**

- have a scientific bachelor's degree, or related to climate change topics;
- be available for a possible transfer in a different location in Italy for the internship (the expenses for the transfer will be paid by the students while the internship will be covered; for information on this regard please address the representative of Deloitte directly).

**Prerequisites**

- to have duly submitted an application for admission to the master's in Science and Management of Climate Change - A.Y. 2024-2025 according to the procedures in art. 3 of the University's Call for Application within the deadline indicated in the Annex Presentation;
- be in possession of the minimum entry requirements (Master's degree).

The evaluation committee will assess the applications received according to the criteria specified below. The criteria for awarding points will be assessed by the committee during the Master's selection interview, after the closing date for applications.

The final ranking list will be published on the Master's website, after the evaluation of the applications.

The contribution will be granted in the form of total exemption from the payment of enrolment fees.

The start and duration of the contribution will be related to the period of the Master's course.

The student judged worthy of the allocation of the enrolment contribution must undertake to sustain the period of internship at the company within the Sustainability 6 Climate Change team in Italy.

**EVALUATION CRITERIA**

- up to 60 points for the grade of the master's degree / v.o. / specialistica based on the grade and relevance to the themes of the Master's degree (60 = 110L);
- up to 10 points for previous professional experience in line with the themes of the Master's degree, also considering voluntary work and internships and study or research experience abroad;
- up to 30 points for the oral interview, during which motivation and knowledge of the topics will be assessed.
