INFORMATION ON THE PROCESSING OF PERSONAL DATA

Pursuant to and in accordance with Article 13 of the EU Regulation 2016/679 ("Regulation"), we inform you that:

a) the data controller is Ca' Foscari University of Venice ("University"), CF 80007720271 with its registered office in Venice, Dorsoduro 3245, PEC: <u>protocollo@pec.unive.it</u>, represented by the Magnifico Rettore *pro tempore*;

b) the University has appointed a "Data Protection Officer," who can be contacted by writing to the email address <u>dpo@unive.it</u> or to the following address: Ca' Foscari University of Venice, Data Protection Officer, Dorsoduro No. 3246, 30123 Venice (VE);

c) your personal data will be processed by the Ca' Foscari University of Venice as part of the management of mobility procedures. The provision of personal data is indispensable for participation in the mobility program and failure to provide them determines the impossibility of participation;

d) the legal basis of the aforementioned processing is Article 6.1.a) of the Regulation ("consent of the data subject"). You may revoke the consent given at any time by writing to the Data Protection Officer at <u>dpo@unive.it</u>;

e) where personal data fall into categories referred to in Article 9 of the aforementioned EU Regulation, all measures will be taken to ensure their accuracy, integrity, confidentiality and minimization, as well as to prevent their undue disclosure;

f) the data will be processed and retained for the time necessary to enable the completion of the project activities referred to in letter (c) above, as well as to comply with the controls required by current regulations. In any case, they will be kept for the time stipulated by the regulations in force regarding the storage and archiving of administrative documentation;

g) the personal data referred to in letter (c) will be processed by means of paper and computer tools and may be made available to national and/or EU public subjects/Authorities for the performance of the controls required by law and to subjects offering instrumental and ancillary services to the University appointed as 'data processors'.
