In spite of the intense commitment and actions taken by the European Union as well as by national governments and regions, much remains to be done in order to dissolve all the barriers to cross-border mobility of people. Issues are not only infrastructural, but also related to administrative and planning coordination. The aim of the workshop is to provide a systematic analysis on what has already been done and what are the next priorities. Scholars and practitioners are invited to submit their researches on the general subject highlighted above. Blind Abstract. The following elements must be included:

• Title of the article.

• Text between 2000 and 4000 characters; detailed description of the research question, method, empirical setting (if any) and conclusions summary.

Accepted paper will be ranked according to the evaluations provided by the reviewers.
