**New call for applications for admission to three-year PhD Programmes for the 37th cycle
(a.y. 2021/2022)**

Additional PON on Research and Innovation 2014-2020 scholarships

The call is issued with Rector's Decree No. 1261 on October, 13rd 2021

Application deadline: 22nd October 2021 at 1.00 pm (Italian Time)

Art. 1 - Purpose of the call and general regulations

1. Following the issue of the Ministerial Decree no.1061 of August 10, 2021, Ca' Foscari University of Venice has been awarded FSE REACT-EU resources for three-year PhD Programmes, active and accredited as part of the 37th cycle (a.y. 2021/2022), to be allocated to support the following two specific measures:
 - additional PhD scholarships on innovation topics (Action IV.4) for PhD students selected on the basis of specific Notices. The aim of the measure is to finance additional PhD scholarships on innovation topics, i.e., PhD Programmes focused on the themes of innovation, enabling technologies and the broader digital topic, such as interventions to enhance human resources in the world of research and innovation;
 - additional PhD scholarships on Green topics (Action IV.5) for PhD students selected on the basis of specific Notices. The aim of the measure is to finance additional PhD scholarships on topics oriented towards ecosystem conservation, biodiversity, as well as towards the reduction of the impacts of climate change and the promotion of sustainable development.
2. In implementation of the above, the new call for applications for admission to the three-year PhD Programmes for the 37th cycle (a.y. 2021/2022) has been launched to award additional PON on Research and Innovation 2014-2020 scholarships (hereinafter PON R&I 2014-2020).
3. This call for applications is published on the Ca' Foscari website at <http://www.unive.it/phd-degrees> > Admission and in the online section of the Official University Register – Albo online (Italian version). Amendments or additions to the call for applications will be published on the same website.
4. Scholarships are offered subject to confirmation of the funding by the Ministry, which is expected approximately by January 2022.
5. The PhD scholarships are all subject-specific and provide for a period of compulsory study and research in the company from a minimum of six (6) months to a maximum of twelve (12) months, pursuant to what the provisions contained in Annex "A", which represents an integral part of this call.
6. Online submission of the application form as set forth in Art. 6 implies the acceptance by the candidate of regulations contained in this call for applications.
7. Ca' Foscari University of Venice will deliver all communications concerning this competitive selection process to candidates by email. The email used will be the one specified by the candidate during registration on the website (Art. 6, paragraph 2). Communications from which the terms of any nature run are considered to have occurred on the date and time certified by the e-mail sent and held by the University.

8. The University shall not be held responsible for any dysfunction due to technical problems and/or overloading communication lines and/or of the OS, for the loss of communications due to incorrect email address details or candidates' failures to communicate changes of email address, nor for any other problems or delays caused by third parties, unexpected occurrences or unforeseeable circumstances.
9. Failure to comply with the rules contained in this call for applications will result in exclusion from the call.

Art. 2 - Call for application and admission criteria

1. Ca' Foscari University of Venice announces the call for **31** additional subject-specific PON R&I 2014-2020 scholarships for admission to the 37th cycle (a.y. 2021/2022) of following three-year PhD Programmes:

2. Admission to the PhD Programmes is granted after being successful in a competition that exclusively provides for the **assessment of qualifications by a single and interdisciplinary University Board**. The composition of Selection Board will be available on the University website at <http://www.unive.it/phd-degrees> > Admission and in the online section of the Official University Register – Albo online - **on October, 27th 2021**.
3. The Courses last three years and, for these specific scholarships, they will start by January 2022. Admission to the PhD requires exclusive and full-time commitment and any incompatibilities with extra academic/training activities of PhD students will be evaluated by the Teaching Board of each PhD Programme. PhD students are required to carry out a mandatory period of study and research in a company from a minimum of six (6) months to a maximum of twelve (12) months pursuant to the provisions contained in Annex "A". They may also carry out research, specialisation and training activities abroad, upon authorisation from the Teaching Board, for a minimum period of six (6) months and a maximum of twelve (12) months, if required by the scholarship research project.
4. The teaching and research activities involved in inter-university Programmes will be organised in coordination with the partner universities. The PhD qualification will be jointly awarded by partners.

Art. 3 - Admission requirements

1. All candidates possessing any of the following requirements can submit their application:
 - "Laurea Specialistica" or "laurea magistrale" (the second cycle degree available in Italy since 1999 after completing five years (or more) of university studies);

- an Italian degree obtained before the system introduced by Ministerial Decree No. 509 dated 3 November 1999 amended by means of Ministerial Decree No. 270 dated 22 October 2004 (*Laurea vecchio ordinamento – Old degree system*);
 - second-level university qualifications granted by AFAM institutions (Alta Formazione Artistica e Musicale, “Advanced Artistic and Musical Training”);
 - **a Master’s degree qualification obtained abroad** – comparable in terms of duration, level and discipline to the Italian qualification granting admission to the PhD Programme – and recognised as suitable for admission to the selection process in accordance with Art. 4 below.
2. **Graduating students** may also apply within the deadline laid down in Art. 6 below, provided they obtain their degree **by October, 31st 2021** (art. 8, paragraph 1 of Ministerial Decree 45 of 8 February 2013). Candidates who do not obtain the qualification within the deadline will be excluded
 3. Candidates are required to have certified English proficiency at least B2 level - under the Common European Framework of Reference for Languages (CEFR) - at the time of enrolment, except for the possibility of acquiring it subsequently, **but no later than April, 30th 2022**, otherwise they shall no longer be able to continue on the PhD Programme. For a list of certificates recognised by the University along with cases of exemption please check the University website at <https://www.unive.it/pag/40886/?L=0>.
 4. No applications will be accepted from candidates already enrolled in other PhD Programmes held by Ca' Foscari University or by partner Institutions in the case of inter-university Programmes.

Art. 4 - International qualifications

1. Candidates must have a qualification that allows enrolment to a PhD Programme in the country where the qualification was obtained. In order to assess the suitability of the qualification obtained abroad, candidates must provide:
 - a) certificate of an academic qualification comparable to *Laurea magistrale* (Master’s degree) or a second level academic degree, preferably translated into English or Italian;
 - b) Transcript of Records from the university that awarded the degree, preferably translated into English or Italian;
 - c) Diploma Supplement (only for students who completed their university degree in EU countries), or Declaration of Value (“*Dichiarazione di valore in loco*”) issued by the competent Italian diplomatic authority in the country in which the qualification was obtained.
2. The suitability of the foreign qualification is verified by the Selection Board according to regulations in force in Italy and in the Country where the qualification itself has been awarded, and while respecting the international agreements concerning the recognition of qualifications for further education.
3. Candidates who do not have the documents referred to the previous paragraph 1, letter c) shall be admitted to the selection procedure conditionally and, if successful, must provide them during the online registration procedure or in any case **by January, 31st 2022**, the Diploma supplement or, if the qualification had been obtained outside the European Union, a copy of the diploma, translated and legalised in Italian or English language, together with Declaration of Value (“*Dichiarazione di valore in loco*”) (*The Declaration of Value is an official document issued by the Italian Embassy in the country in which the qualification was issued*), prepared by the Italian diplomatic-consular Representation, that is located in the Country where the qualification was obtained.
4. In the event that the aforementioned documents provided by the candidate show the academic qualification to be invalid for the purposes of enrolment on an academic course equivalent to a PhD, the person concerned shall no longer be able to continue on the PhD Programme and must return any funding already received.
5. At any time, the candidate may be required to supplement the documentation submitted in order to check its admissibility.

Art. 5 - Assessed qualifications

1. Candidates must present the following mandatory qualifications for admission to all the PhD Programmes of the current call:
 - **Curriculum vitae et studiorum;**

- **Certificate of Master’s degree exams passed with grades** (Italian and European Community citizens are merely required to submit a Personal Declaration of Certification under the Presidential Decree No. 445 dated 28 December 2000, No. 445 as amended by Art. 15 paragraph 1 of Italian Law No. 183 dated 12 November 2011)¹;
- **Research project on the topic of the scholarship for which candidates wish to participate, in accordance with the provisions of Annex “A”.** Each candidate may submit a single research project, in which he must specify the research topic he is applying for. The research project presented for the selection will not necessarily be the one developed by the PhD student during the PhD programme.

Candidates must refer to the following criteria while drafting the project, pursuant to art. 3 of Ministerial Decree 1061 of 10 August 2021:

2. Candidates may also attach optional qualifications to the application (e.g., post-graduate academic qualifications, post-graduate scholarships, certification relating to research activities in public and/or private entities, etc.) including publications, which they deem relevant to the research topic of the scholarship they wish to apply for.
3. Qualifications must be attached to the online application form according to the procedure in Art. 6 below.

¹ Under the Presidential Decree No. 445 dated 28 December 2000 as subsequently amended, Italian and EU citizens only need to submit a Declaration of Certification concerning the following statuses and personal facts, certified by Public Administrations: a) inclusion on registers or lists kept by Public Administrations; b) membership of professional associations; c) qualification, examinations passed; d) professional qualification, specialisation, licence, training, refresher course or technical qualification; e) student status.

The Declaration of Certification must be duly signed. Non-EU citizens may use the Declaration of Certification limited to the states and to the facts that can be attested by Italian public subjects or in cases where the production of a Declaration of Certification takes place in application of international agreements between Italy and the country of origin of the declarant.

Art. 6 - Application form

1. The application form must be submitted to the PhD Office **by 1.00 pm (Italian time) on Friday October, 22nd 2021** according to the online procedure described in paragraph 2 below; failure to do so will result in exclusion from the selection process. This online procedure is available on the University website at <https://www.unive.it/pag/20822/>.
2. The procedure involves two stages, each of which is obligatory in order to participate in the selection process:
 - a) **completing and saving the admissions application online via the specific link given for each PhD Programme.** The application can only be considered saved when the candidate receives a submission confirmation email with a unique application code. This code will be used to identify the candidate;
 - b) **registration on the University website** by accessing the page www.unive.it/registration, which is compulsory in order to be able to confirm admission to the PhD Programme upon selection, as per art. 10.

If you have already registered (e.g., to take part in previous years' calls for applications or as a former student of Ca' Foscari) this step must be skipped.

Access to the reserved area for confirmation purposes can take place in three ways, depending on the status of the applicant:

- those who have a student number and a password (as former students of the University) can log in with their credentials;
- once registered, applicants of Italian nationality or currently residing in Italy who do not have a student number and a password must log in through SPID.

- once registered, applicants of a nationality other than Italian who are not currently in Italy and have no student number and password may request credentials via the link www.unive.it/nospidaccess.

3. Qualifications and publications, as described in Art. 5, must be submitted in PDF format (maximum file size is 10 MB) and uploaded only during the compilation of the online application form. Candidates may add, cancel or modify the documents after the completion of the online application form described in section 2 above, provided they do so before the deadline of the application process. **It is compulsory to attach a copy of a valid identity document.**
4. Candidates who intend to participate in several PhD Programmes will have to present separate application forms, enclosing the necessary documents for each of PhD Programmes.
5. All documents in the previous paragraph 3 must be written preferably in Italian or English, or translated into Italian or English by and under the responsibility of the candidates.
6. With the exception of access qualifications described in Art. 3, paragraph 2 above, all qualifications must be obtained by the application deadline.
7. If the candidate is a graduating student, he must communicate, by November 2nd 2021, the achievement of qualification to the PhD Office by email to phd.application@unive.it, sending exclusively the Declaration of Certification if he is an Italian or an EU citizen in possession of a qualification obtained in Italy. For qualifications obtained abroad, candidates must send appropriate certification of the achievement of the degree.
8. **Applications lacking the compulsory qualifications described in Art. 5 above will not be considered.**
9. The University will check the validity of all applications after the submission deadline. Candidates who submitted invalid applications will be excluded from the selection process and informed by email.
10. Candidates will be admitted to the selection process with the proviso that admission requirements are met; the verification procedure will be carried out in compliance with Art. 43 of Presidential Decree No. 445 dated 28 December 2000, n. 445. The University reserves the right to exclude candidates from the selection process at any time: the communication will be given using the e-mail address indicated by the candidate, pursuant to art. 6, paragraph 2. The University will also verify the truthfulness of Personal Declarations of Certification submitted by candidates: anyone submitting false declarations will be punishable under the Italian Penal Code and all applicable laws.

Art. 7 - Selection Board and criteria for qualification assessment

1. There is a single and interdisciplinary Selection Board made up of five members, including the President.

2. The Board may be supported by the Coordinators of the PhD Programmes as consultants, with no right to vote, exclusively in charge of supporting the assessment process.
3. The Selection Board may use IT tools to carry out the work.
4. The Board may award 100 points: 70 for compulsory qualifications and 30 for optional qualifications. The minimum score for eligibility is 60/100.
5. The Board establishes the assessment criteria and the scores assigned to the qualifications in implementation of the previous paragraph.
6. During the assessment of qualifications, the Board may integrate the statements made by the candidates with the information contained in the *curriculum vitae et studiorum* attached to the application form.
7. While assessing applications, the Board will also take into account the criteria set out in art. 5, pursuant to art. 3 of Ministerial Decree 1061 of 10 August 2021.

Art. 8 - Final shortlist

1. Eligible candidates will be admitted to each PhD Programme according to the shortlist until all available places are filled.
2. Admission to each PhD Programme will be exclusively established by the online shortlists published on the University website <http://www.unive.it/phd-degrees> > Admission and in the online section of the Official University Register – Albo online, **on November, 11th 2021**. Publication of this shortlist fulfils the document publication requirement: names will be indicated for successful and eligible candidates only. Candidates admitted will not receive personal communications.
3. PhD scholarships – described in Art. 9 – will be allocated according to the shortlist, regardless of candidates' citizenship. In case of equally ranked candidates, scholarship allocation will take into account the candidate's household income (calculated according to the criteria set out in the current legislation governing access to higher education).
4. Candidates ranked in more than one shortlist must choose one PhD Programme only.
5. PhD scholarships will be assigned by the Selection Board on the basis of affinity with the research topics of candidates' qualifications and their academic profile.
6. The candidates admitted are required to develop the theme of the research indicated by the scholarship during the course of their studies.

Art. 9 - PhD scholarships

1. The PhD scholarship, which will be paid in monthly instalments, is €15,343.28 per year (including social insurance contributions payable by the scholarship holder). The PhD scholarship is exempt from local tax and income tax (IRPEF)².
2. The PhD scholarship is renewable on an annual basis for the entire duration of the Programme on the condition that the holder has completed the Programme of activities provided from year to year, verified by the Teaching Board.
3. The PhD scholarship PON R&I 2014-2020 may be increased by up to 50% for a period of up to 12 months if provided for by the research project of the scholarship and the PhD student is authorised to carry out research activities by the Teaching Board.
4. From the second year onwards, all PhD students with PhD scholarship are entitled to a budget for research activities in Italy and abroad, for an amount that is equal to at least 10% of the PhD scholarship.
5. PhD scholarship cannot be combined with either research grants and research scholarships or other scholarships assigned for any reason whatsoever, with the exception of those granted by national or foreign institutions to integrate research or study periods abroad.
6. Candidates who received a PhD scholarship in the past cannot receive it again.
7. Each PhD student will have to report on the activities carried out every two months, by drafting a report indicating the duration of commitment (divided into months, in the company, on site, abroad if required) and a summary of the main activities carried out. Specifically, reports will be submitted through the specific online platform <http://dottorati.miur.it> and through the forms therein. The Coordinator of the PhD Programme, through the same platform, will be in charge of assessing and validating the information submitted by the PhD student.
8. For the PON R&I 2014-2020 scholarship holder it is not possible to renounce the scholarship and continue the PhD programme.

² The net annual amount of the scholarship is about € 13.500.

9. In the event of failure to obtain the degree or in the event that the PhD student is not positively assessed for the purpose of renewal of the scholarship, or in the event that the student withdraws from the PhD Programme, the Ministry will partially revoke the funding. In the event of withdrawal, the PhD student is required to return the amounts paid in relation to the academic year being attended at the time of the withdrawal.

Art. 10 - Accepting the place and enrolment

1. Under the penalty of exclusion, successful candidates must **by November 15th 2021**:

- a) complete the online enrolment procedure;
- b) pay the tax stamp and the regional tax for financial aid (*tuition fees*).

A specific declaration must be attached to the online enrollment application in which candidates:

- a) take note of the provisions of Ministerial Decree no. 1061 of 10 August 2021;
 - b) formally undertake to carry out the scheduled research periods (minimum 6 months, maximum 12 months) in the company and abroad (optional), while certifying that they are aware that failure to comply with the minimum company period will result in the revocation of the scholarship;
 - c) certify that they are aware that the modification of the project objectives and the expected results (if not previously authorised by the MUR) will imply the revocation of the scholarship and the total refund of any amounts already paid;
 - d) certify that they are aware that any negative judgment of the Teaching Board and the consequent non-admission to the following year of the PhD Programme will result in the revocation of the amounts already paid for the current year, and that failure to obtain the degree will result in the revocation of the amounts already paid for the last year of the course;
 - e) certify that they are not currently benefiting from other scholarships awarded for any reason, and undertake, for the entire duration of the additional scholarship, not to benefit from other scholarships awarded for any reason, except for those admissible pursuant to of the national legislation in force.
2. To fill in the online application form, it is necessary to access the Reserved Area of the website in the manner set out in art. 6, paragraph 2, and proceed as follows: Home > Student services > Enrolment (former students should instead proceed as follows: Admission > Enrolment).
As to the documentation to be attached in this phase, please refer to the provisions on the University website at <http://www.unive.it/dottorati> > [select ENG] Admission > Enrolment
During the application process, the applicant must pay the relevant fees exclusively via PagoPA by clicking on the 'Pagamenti' button at the end of the procedure.
The page <http://www.unive.it/dottorati> > [select ENG] Admission > Enrolment contains instructions on how to make the payment. In case of non-funding of the scholarship by the Ministry, the candidate will be reimbursed the amount of the regional tax for financial aid.
3. The submission of the enrolment application and the payment of the fees due within the established deadlines are mandatory for the purpose of accepting the place, under penalty of exclusion.
 4. The enrolment procedure will be completed by the Post Lauream Office following confirmation of the funding by the Ministry, which will be communicated by e-mail to the interested candidates. For students residing in non-EU countries, enrolment will be finalised only after they have obtained a visa. Each successful candidate will receive an email with an enrolment reminder containing the access credentials (student identification number and password) for the university website and IT services.
 5. The Settore Orientamento e Accoglienza / Counselling and Welcome Sector will provide support to non-Italian winners for administrative formalities, such as the issue of visas, residence permits and tax codes, registration in the separate INPS scheme.
 6. Candidates cannot be enrolled in other PhD Programmes or other university courses held in other universities or research institutions, either in Italy or abroad, at the same time, except for International PhD Programmes and co-tutorship agreements (co-tutela). If already enrolled in a university Programme, candidates must suspend their studies, if provided for under current law, for the entire duration of the PhD Programme, following the procedure established by the University where they first enrolled.

Art. 11 - Waiver and replacement

1. In case of waiver, the candidate is required to notify via e-mail to postlauream@unive.it by November 15th 2021. Once this deadline has elapsed without any explicit notification of waiver being received, the candidate will in any case be considered withdrawing.
2. In case of waiver of one of the candidates, the place will be assigned according to the final shortlist order and according to

the criteria expressed in art. 8, paragraph 5. Candidates will be notified only by email. Acceptance must take place within two (2) working days from the date of communication, with the same procedure indicated in art. 10, paragraphs 1 and 2.

3. If the candidate renounces after he accepted the place, the amounts of the fees paid will not be returned.

Art. 12 - Tuition fees

1. The amount for university fees in the a. y. 2021/2022 includes:
 - a) tax stamp of € 16.00;
 - b) the regional tax for financial aid of € 173.00;
2. All PhD students are only required to pay tax stamp and the regional tax for financial aid.
3. The amount of the regional tax for financial aid may be further reduced on the basis of the student's financial condition. Student fees will be calculated on the basis of the ISEE declaration including all reductions available to each student. Information regarding how to access fee reductions and relative deadlines and for presenting the ISEE form can be found at the Ca' Foscari University website: <http://www.unive.it/phd-degrees> > Admission > Tuition fees.

Art. 13 - Privacy of personal information

1. The University undertakes to use the personal data provided by the candidate for the fulfilment of the call procedures and for institutional purposes in compliance with the provisions laid down in Regulation EU 2016/679 ("General Data Protection Regulation - GDPR") and applicable national legislation (Legislative Decree 30 June 2003, no. 196 "Code regarding the protection of personal data") as amended from time to time. The information on personal data processing are published online at: www.unive.it/pag/36172/.
2. In compliance with the principles set out in the aforementioned law, participation in the competition implies consent to the publication of the personal data of successful and eligible candidates on the University website.

Art. 14 - Ownership and publication of the results

1. By participating in this call, the candidate accepts the provisions contained in the University Regulation regarding patents, available on the University website, page <https://www.unive.it/pag/8261> and in particular the provisions and obligations laid down in article 14 ("Obligations and rights of non-employees").
2. In case of enrolment, the candidate undertakes to sign suitable declaration on the matter.

Art. 15 - Reference regulations and offices responsible

1.
