#### INFORMS

#### **ART. 1 - INTRODUCTION AND PURPOSE**

- 1. The admission procedure for educational activities called "microcredentials" is now open.
- 2. Microcredentials certify the learning outcomes of a short, voluntary learning experience, such as a course or short-term training. They provide a flexible and targeted way to help students develop knowledge, skills, and competencies for personal and professional growth.
- 3. The Venice School of Management offers microcredentials within the following Master's Degree Programmes:
  - [EM60] Management and Sustainability
  - [EM16] Global Accounting and Finance
  - [EM17] Innovation and Marketing
  - [EM18] International Management
- 3. Microcredentials involve 15 hours of teacher-led activities, either online or in-person, and enable the earning of 3 CFU (ECTS). Students interested in participating must add this to their study plan. When filling in the study plan, on the Tirocinio/Internship page, students must choose the block corresponding to 6 CFU (ECTS) for the internship and 3 CFU (ECTS) for the microcredential.

- 5. The microcredentials activated for the 2024/2025 academic year are as follows:
  - Laboratory for Professionals: Certified Public Accountants (taught in English)
  - Analisi degli standard EFRAG per le PMI in tema di report di sostenibilità (Analysis of EFRAG standards for SMEs on sustainability reporting, taught in Italian)

- User Experience for Marketers (taught in English)
- Al Powered Innovation (taught in English)
- Le transizioni dell'ecosistema automotive: tecnologia, innovazione, competenze (Transactions in the automotive ecosystem: technology, innovation, skills, taught in Italian)
- Venture Capital (taught in English)

#### ART. 2 – RECIPIENTS

- 1. Participation is limited to a set number of students:
  - Laboratory for Professionals: Certified Public Accountants: <u>20 students</u> from the Master's Degree Programme in <u>Global Accounting and Finance [EM16]</u>. Students enrolled in master's degree programmes that have included 3 CFU (ECTS) of microcredentials in their study plan can also participate, according to this order of priority: International Management [EM18], Management and Sustainability [EM60] and Innovation and Marketing [EM17].
  - Analisi degli standard EFRAG per le PMI in tema di report di sostenibilità: <u>30 students</u> from the Master's Degree Programme in <u>Management and Sustainability [EM60]</u>. Students enrolled in master's degree programmes that have included 3 CFU (ECTS) of microcredentials in their study plan can also participate, according to this order of priority: International Management [EM18], Innovation and Marketing [EM17], Global Accounting and Finance [EM16].
  - User Experience for Marketers: <u>20 students</u> from the Master's Degree Programme in <u>Innovation and Marketing [EM17]</u>. Students enrolled in master's degree programmes that have included 3 CFU (ECTS) of microcredentials in their study plan can also participate, according to this order of priority: International Management [EM18], Management and Sustainability [EM60], Global Accounting and Finance [EM16].
  - **AI Powered Innovation**: <u>25 students</u> from the Master's Degree Programmes in International Management [EM18], Management and Sustainability [EM60], Global Accounting and Finance [EM16], Innovation and Marketing [EM17].
  - Le transizioni dell'ecosistema automotive: tecnologia, innovazione, competenze: <u>30</u> <u>students</u> from the Master's Degree Programmes in Management and Sustainability [EM60], International Management [EM18], Innovation and Marketing [EM17], Global Accounting and Finance [EM16].
  - Venture Capital: <u>30 students</u> from the Master's Degree Programmes in Global Accounting and Finance [EM16], International Management [EM18], Management and Sustainability [EM60] and Innovation and Marketing [EM17].
- 2. A number of students equal to the remaining unassigned places following the first admission procedure will be admitted to each microcredential.

- 3. Students enrolled in the Master's Degree Programmes in Marketing and Communication [EM7] and Administration, Finance and Control [EM4] can also participate in microcredentials, if they include this activity as an extra. Their participation is subject to the availability of places, given that the priority order by Degree Programme described in the previous paragraph will be followed.
- 4. Students who are not regularly enrolled in one of the master's degree programmes listed in the previous paragraphs for the 2024/2025 academic year will not be admitted.

# ART. 3 – DEADLINES AND METHODS OF PARTICIPATION

- 1. To participate in the microcredentials, the students referred to in the previous Art. 2 must complete the application form available online at the following links **by 12:00 p.m. on March 13, 2025**:

- 2. Those who wish to apply for more than one microcredential must complete one online form for each.
- 3. We will immediately exclude candidates whose applications are found to be:
  - a) sent in after the deadline;
  - b) incomplete or incorrect;
  - c) not submitted through the dedicated University link;
  - d) containing false statements.
- 4. Applications that do not follow the submission method specified in Article 3, paragraph 1 will be considered inadmissible and will not be accepted.

# ART. 4 – ADMISSION

 A special committee will draw up the list of admitted students after evaluating the applications in order of date and time of submission. Degree programme priorities are described in Art. 2, paragraph 1.

- 2. The list of admitted students for each microcredential will be published by 21/02/2025 on the page https://www.unive.it/web/it/6639/microcredenziali-3-cfu
- 3. By 26/02/2025, 12:00 noon, admitted students must email <u>didattica.management@unive.it</u> a declaration of acceptance of participation in the micro-credential or micro-credentials for which they are eligible.
- 4. By the same deadline, students who no longer wish to participate in the microcredential or microcredentials to which they have been admitted must email a declaration of withdrawal to <u>didattica.management@unive.it</u>. If an admitted student withdraws, the students on the waiting list will be called up and admitted following the ranking. The Educational Programmes Office of the Venice School of Management will communicate the new admission via email.
- 5. If the admitted student does not send either a declaration of acceptance or a declaration of withdrawal by the deadline of 26/02/2025, the Educational Programmes office will proceed with the student's exclusion and the consequent scrolling of the ranking.

# ART. 5 – ATTENDANCE

- Attendance at microcredentials is mandatory. Justified absences are allowed within the limit of 30%. Failure to comply with attendance requirements precludes the registration of the 3 CFU (ECTS) and the issuance of the Open Badge.
- 2. Students can request to withdraw from the microcredential to which they have been admitted at any time. The request is irrevocable and must be emailed to <u>didattica.management@unive.it</u>.
